### FACTS

#### WHAT DOES STRATATECH EDUCATION GROUP DO WITH YOUR PERSONAL INFORMATION?

##### Why?

### Who we are

**Who is providing this notice?**

TWS Acquisition Corporation d/b/a StrataTech Education Group focuses on the development of specialized career education schools, particularly skilled-trade programs designed to address the nation's growing infrastructure needs.

### What we do

**How does StrataTech Education Group protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

**How does StrataTech Education Group collect my personal information?**

We collect your personal information, for example, when you

- complete an online request for information form
- call a campus to request information

**Why can't I limit all sharing?**

Federal law gives you the right to limit some but not all sharing related to:

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws may give you additional rights to limit sharing.

### Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include companies that utilize the names Tulsa Welding School, Tulsa Welding School & Technology Center, or The Refrigeration School.

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- StrataTech Education Group does not share with nonaffiliates so they can market to you.

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- StrataTech Education Group does not engage in joint marketing with nonaffiliated financial companies.

### Other important information

**Important Notice about Credit Reporting:** We may report information about your account(s) to credit bureaus and/or consumer reporting agencies. Late payments, missed payments, or other defaults on your account(s) may be reflected in your credit report and/or consumer report.

**Do Not Call Policy:** This notice is the StrataTech Education Group Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on state or federal Do Not Call lists, unless the law allows. StrataTech Education Group employees receive training on how to document and process telephone marketing choices.
